### VII.2.1) Description of the modifications

Nature and extent of the modifications (with indication of possible earlier changes to the contract): Diese MKF behandelt die Mehrkosten in Zusammenhang mit den Änderungen bei Herstellung der Entwässerungsquerung in der Hafestraße aufgrund der Hindernisse bei der Rohrpressung. Bei der Herstellung der Rohrpressung für die Entwässerungsquerung der Hafestraße wurden Findlinge angefahren, sodass die Pressung abgebrochen werden musste. Ein zweiter Versuch mit geänderter Lage und Vortriebsrichtung war ebenfalls nicht erfolgreich. Daher wurde der restliche Teil der Entwässerungsquerung „konventionell“ in mehreren Phasen mittels Bagger hergestellt. Die Phasen waren von den Straßensperren bzw. Teilsperren der Hafestraße abhängig.
