II.2.4) Description of the procurement: Die A9 Pyhrn Autobahn stellt nicht nur im innerösterreichischen Verkehrsnetz die Verbindung der Industriezentren von Linz und Graz dar, sondern hat eine weit darüber hinausgehende internationale Bedeutung im Europäischen Verkehrsnetz. Als E 57 ist die A9 Teil einer Nordwest – Südost Achse über den niedrigsten Ostalpenübergang und verbindet überregional Nürnberg mit Zagreb. Damit stellt sie einen Transitweg in die Südostregion Europas (Türkei, Griechen-land) dar. Die A9 verläuft vom Knoten „Voralpenkreuz“ / Oberösterreich (A1/ A8 / A9) über 220 km bis zur Österreichisch – Slowenischen Staatsgrenze bei Spielfeld / Steiermark. Der Tunnel Schartnerkogel befindet sich im Bezirk Graz Umgebung Ortsteil Deutscheitz auf Autobahnkilometer km 162,520 – km 163,844. Im Schartnerkogeltunnel befinden sich zum Teil noch Einrichtungen der BuS Aus-stattung aus der Ersterrichtung. In den Jahren 2001-2002 wurden erste Maßnahmen zur Erhöhung der Tunnelsicherheit durchgeführt. Im Jahr 2005 wurden die Innenstreckenbeleuchtung und die Steuerung der Tunnellüftungsanlage erneuert. Im Jahr 2010 wurde die Tunnelfunkanlage erneuert und abschließend im Jahr 2018 erfolgte eine Anpassung an das STSG.
