3.Explanation

Aufgrund der Situation, die durch die COVID-19 Pandemie bestimmt wird, besteht in Österreich ein dramatisch erhöhter Bedarf an medizinischen Produkten wie dem gegenständlichen Auftragsgegenstand. Aus Sicht des Auftraggebers liegen jedenfalls (i) ein unvorhersehbares, nicht dem Auftraggeber zurechenbares Ereignis (Ausbreitung des Corona-Virus [COVID-19] als Pandemie), (ii) dringliche und zwingende Gründe, die die Einhaltung der vergaberechtlich vorgeschriebenen Fristen nicht zulassen (die Versorgung der Bevölkerung mit medizinischen Produkten duldet keinen Aufschub), und ein offenkundiger Kausalzusammenhang zwischen (i) und (ii) vor. Aufgrund des Vorliegens dieser äußerst dringlichen, zwingenden Gründe wie die dringend nötige Eindämmung der Pandemie, die Behandlungsnotwendigkeit und der Schutz des medizinischen Personals kommt die Anwendung eines Verhandlungsverfahrens ohne vorherige Bekanntmachung zum Tragen, da Waren beschafft werden sollen, die angesichts der Notsituation unmittelbar und dringend erforderlich sind. Aus Dringlichkeitsgründen kann unter den gesetzlichen Voraussetzungen ein Verhandlungsverfahren ohne vorherige Bekanntmachung durchgeführt werden.
